SUBJECT	DISCUSSION	ACTION TAKEN
April 27-28 board meeting minutes	Minutes reviewed. No changes noted	Minutes approved, 3/0
Secret shopper program	Discussed the use of pharmacy students or a temporary employee (via Adecco etc.) to evaluate a pharmacy checking ID's or making the offer to counsel for new prescriptions. The emphasis of this program would be to evaluate and inform pharmacists through the board newsletter as well as a letter back to each pharmacy regarding findings at their pharmacy.	Staff to have a proposed plan for discussion at the October meeting. Tentative timetable would be spring 2006. Dean Vandell will be contacted regarding the use of pharmacy students.
Approval of colleges/schools of pharmacy	As allowed by W.S. § 33-24-116, the board reviewed the current directory of accredited professional programs of colleges and schools of pharmacy by the Accreditation Council for Pharmacy Education (A.C.P.E.) and discussed accepting this listing as those colleges or schools of pharmacy, which would be accepted by the board for those applicants seeking pharmacist licensure by examination, score transfer, or license transfer as well as those applicants seeking registration as a pharmacy intern. In addition the board discussed accepting applicants who have graduated from a foreign pharmacy school.	Board voted 3/0 to accept the current directory of accredited professional programs of colleges and schools of pharmacy by the Accreditation Council for Pharmacy Education (A.C.P.E.) as the approved listing of schools/colleges of pharmacy. In addition, the board will consider a change in rule to allow foreign pharmacy school graduates to obtain licensure as a pharmacist in Wyoming. This will be considered during rule-making in 2006.
BFY 07-08 budget	Discussed timeframe for submission of the board's budget. Budget is to be submitted to Cheyenne by August 26th.	Board to be updated as budget is prepared.
Proposed rule changes	Proposed changes in Wyoming Pharmacy Act Rules & Regulations as well as the Wyoming Controlled Substance Act Rules & Regulations were reviewed, discussed and changes proposed. This was the second board meeting where the proposed changes were discussed.	Revised proposed rules will be posted on the board's web site and dated 6/28/05. Proposed rules will be reviewed at the July 14th board meeting. A rule-making notice will be published in late July or early August. A public hearing to hear public comments on changes proposed in the rule-making notice will be scheduled for October 5, 2005 in Jackson, WY.
